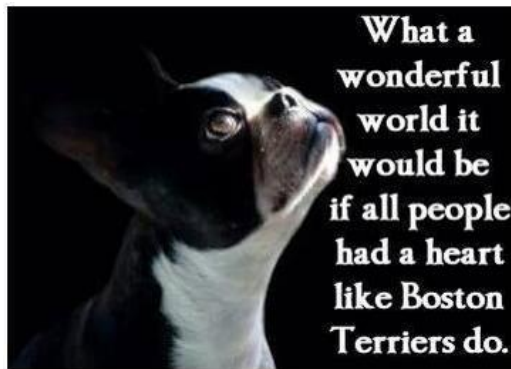

This contract is for the sale/purchase of a registered/registerable;

AKC (American Kennel Club) Boston Terrier.

- 1. A deposit will hold the puppy/adult until time of delivery. Deposits are nonrefundable, unless there is a genetic problem with the puppy after its medical exam determined by our licensed vet. In such a case, the buyer has the option to pick another available puppy or move deposit to another litter.**
- 2. Deposits are refundable or can be transferred to next available litter if puppy dies while in our care. Full payment is required once the puppy reaches the age of 8 weeks or all monies paid and all claims to the puppy/adult will be forfeited. If the puppy is being delivered, the transportation fee must be made in full, 10 days prior to delivery.**
- 3. Puppies will be delivered between 8 and 12 weeks of age after age appropriate shots have been given. We do not ship our puppies.**
- 4. The puppy/adult will come with a wellness checkup from our licensed vet and/or a health certificate, a shot record stating which inoculations have been given and health testing results done on parents are available upon request.**
- 5. Puppy/Adults are sold as "Pet Quality" with either Full or Limited registration upon approval.**
- 6. Joyful Heart Boston Terriers doesn't guarantee show or breeding quality, even though we strive to accomplish it. There will be a separate contract for breeding prospects sold on full registration and a separate contract for pet prospects sold on limited registration with attached spay and neuter contract.**

HEALTH GUARANTEE AND BREEDER AND BUYER CONTRACT AGREEMENT

IN ORDER FOR THE HEALTH GUARANTEE TO BE VALID THE BUYER AGREES TO TAKE THE PUPPY/ADULT TO A VETERINARIAN WITHIN 48 HOURS OF THE DATE OF PURCHASE FOR A PHYSICAL EXAMINATION, TO EVALUATE THE HEALTH OF THE PUPPY AT THE TIME OF SALE. IF POSSESSION OCCURS ON THE WEEKEND OR A HOLIDAY, THE BUYER SHALL HAVE AN ADDITIONAL 24 HOURS TO HAVE THE PUPPY EXAMINED. FAILURE TO NOTIFY JOYFUL HEART BOSTON TERRIERS BY EITHER E-MAIL OR PHONE OF THE VETERINARIAN'S REPORT OF THE PUPPY WITHIN 2 BUSINESS DAYS FROM THE EXAMINATION WILL VOID AND NULLIFY ALL HEALTH GUARANTEES. THE BREEDER DOES NOT ASSUME ANY LIABILITY FOR INJURY TO THE PUPPY/ADULT AFTER HAND DELIVERY.

IF THE PUPPY IS FOUND TO HAVE A LIFE THREATENING CONGENITAL DEFECT (WHICH MEANS HE/SHE WILL DIE FROM THE DEFECT) AT THE TIME OF YOUR EXAM OR UP TO TWO YEARS FROM DATE OF BIRTH, THE BREEDER MUST BE CONTACTED.

A WRITTEN COPY OF THE REPORT MUST BE E-MAILED TO US WITHIN 2 BUSINESS DAYS OF THE LICENSED VETERINARIAN DETERMINATION AND HAVE ONE (1) WRITTEN REPORT FROM AN UN-ASSOCIATED VETERINARIAN STATING THE PROBLEM. THE BREEDER WILL PROVIDE TO SELLER A RE-PLACEMENT PUPPY OF COMPARABLE QUALITY, SAME COLOR, AND SAME SEX WHEN POSSIBLE AND WHEN ONE BECOMES AVAILABLE.

THE PUPPY NEEDS TO BE RETURNED WITHIN 1 WEEK.

IF THE **BUYER** CHOOSES TO RETURN THE PUPPY, THE PUPPY
WILL BE RETURNED ALONG WITH ALL REGISTRATION PAPERS AND ALL DOCUMENTS THAT CAME WITH
THE PUPPY AT TIME OF PURCHASE, AT THE **BUYERS** EXPENSE. THE REPLACEMENT PUPPY WILL
BE DELIVERED AT THE **BREEDER'S** EXPENSE. IF **BUYER** CHOOSES TO KEEP THE PUPPY THEN
NO REPLACEMENT PUPPY WILL BE GIVEN UNTIL TIME OF DEATH, BUT A DISCOUNT MAY BE
APPLIED TOWARD ANOTHER PUPPY MUTUALLY AGREED UPON BETWEEN **BREEDER** AND **BUYER**.
NO REFUNDS WILL BE ISSUED, ONLY REPLACEMENT PUPPY. THE **BREEDER** IS NOT
RESPONSIBLE FOR ANY MEDICAL EXPENSE INCURRED. WE WILL NOT GUARANTEE AGAINST
COMMUNICABLE DISEASES, SUCH AS COCCIDIA OR GIARDIA.

A) IF A PUPPY IS BEING RETURNED TO THE **BREEDER**, THE RETURNED PUPPY MUST BE
RETURNED IN A GOOD HEALTHY CONDITION, OTHER THAN THE SPECIFIED PROBLEM, AT THE
BUYER'S EXPENSE. THE PUPPY NEEDS TO BE RETURNED WITHIN 1 WEEK. THE **BUYER** WILL
THEN QUALIFY FOR A REPLACEMENT PUPPY.

B) THE REPLACEMENT PUPPY WILL BE MUTUALLY AGREED UPON BY BOTH **BREEDER** AND
BUYER AND WILL BE OF COMPARABLE QUALITY, SAME COLOR, SAME SEX (IF AVAILABLE). IT IS
UNDERSTOOD THE REPLACEMENT PUPPY MAY NOT BE FROM THE EXACT SAME PARENTS OF THE
ORIGINAL PUPPY. THE REPLACEMENT PUPPY WILL BE DELIVERED AT THE **BREEDER'S** EXPENSE.

C) NO REPLACEMENT PUPPY WILL BE GIVEN IF THE PUPPY HAS BEEN EUTHANIZED WITHOUT
THE PERMISSION OF THE **BREEDER**, BEFORE A CONSULTATION WITH THE TREATING
VETERINARIAN. THE EXCEPTION TO EUTHANASIA WOULD BE IN THE CASE OF SEVERE INJURY OR
SUFFERING ON THE PART OF THE ANIMAL.

THE **BUYER** AGREES TO PROVIDE THE DOG WITH BASIC OBEDIENCE TRAINING, SOCIALIZATION,
ADEQUATE FOOD, FRESH WATER, SHELTER, MEDICAL CARE INCLUDING ALL NECESSARY SHOTS,
HEART-WORM PREVENTION, ANNUAL FECAL EXAM, RABIES VACCINATION AND ANY MEDICATION
RECOMMENDED BY THE VETERINARIAN. IF THE PUPPY IS USED FOR BREEDING BEFORE 12

MONTHS OF AGE, THIS WILL VOID THE GUARANTEE.

WORMS, COCCIDIA, GIARDIA AND KENNEL COUGH ARE NOT A REASON TO RETURN A PUPPY.

PUPPIES ARE WORMED WITH TWO DIFFERENT WORMERS ALTERNATING EACH TIME WORMED AND

EVERY MEASURE IS TAKEN TO PREVENT PARASITES.

**KENNEL COUGH IS SELF-LIMITING AND LIKE THE COMMON COLD, MUST RUN ITS COURSE. UNDER
NO CIRCUMSTANCES WILL THE BREEDER BE RESPONSIBLE FOR ANY TYPE OF VETERINARY BILLS OR**

**ANY TRANSPORTATION COST OF ANY KIND AT ANY TIME, EXCEPT NOTED FOR REPLACEMENT
PUPPY. ALL VETERINARY AND TRANSPORTATION COST ARE THE RESPONSIBILITY OF THE BUYER.**

**THE FOLLOWING IS NOT COVERED IN THE HEALTH GUARANTEE: ERECT EARS, UNDER/OVER
BITE, CHERRY EYE, STENOTIC NARES (COLLAPSED/PINCHED NOSTRILS), ENTROPION, ELONGATED
SOFT PALATE, PARTIAL DEAFNESS, LOOSE PATELLA'S, DEAFNESS, AND/OR ANY MINOR CONDITIONS
COMMON TO THE BOSTON TERRIER BREED. HOWEVER, SHOULD ONE OF THESE CONDITIONS
ARISE, WE WOULD BE WILLING TO OFFER A DISCOUNT TOWARD THE PURCHASE OF ANOTHER PUPPY**

**WITH WRITTEN DOCUMENTATION FROM A LICENSE VET THE SEVERITY OF THE PROBLEM AND
DIAGNOSIS.**

**A) THERE ARE CERTAIN DISORDERS THAT MAY BE CAUSED BY ENVIRONMENTAL FACTORS, FOR
EXAMPLE: SEASONAL/ SKIN ALLERGIES, THYROID DYSFUNCTION, DEMODECTIC MANGE,
DERMATITIS AND OTHER AUTOIMMUNE DISORDERS THAT ARE NOT COVERED BY THIS GUARANTEE.**

**B) WE DO NOT GUARANTEE AGAINST CONDITIONS THAT MAY OR MAY NOT BE STRESS RELATED
FROM THE MOVE TO A NEW HOME AND/OR BY THE TRANSPORTATION PROCESS. THE STRESS
RELATED CONDITIONS THAT HAVE PREVIOUSLY REMAINED DORMANT CAN BE TRIGGERED BY THE
ABOVE AND UNFORTUNATELY CANNOT BE DIAGNOSED UNTIL AN ACTIVE CASE BECOMES EVIDENT.**

**SOME OF THESE STRESS RELATED CONDITIONS OR ILLNESSES ARE: COCCIDIA, KENNEL COUGH
AND HYPOGLYCEMIA (LOW BLOOD SUGAR).**

**THE FOLLOWING ARE COVERED IN THE HEALTH GUARANTEE: JUVENILE HEREDITARY BLINDNESS,
CARDIAC ISSUES, ANY LIFE THREATENING CONGENITAL DEFECT.**

ALL GUARANTEES ARE VOID IF THE DOG HAS BEEN BRED LESS THAN 12 MONTHS OLD,
OVERWEIGHT, MALNOURISHED, KEPT IN AN IMPROPER ENVIRONMENT, OR IS INJURED DUE TO
NEGLECT.

THIS CONTRACT ONLY APPLIES TO THE ORIGINAL BUYER AND IS NULL AND VOID IF OWNERSHIP IS
TRANSFERRED. ALL SALES ARE CONSIDERED INITIATED, TRANSACTED AND FINALIZED IN LINCOLN
COUNTY, TN.

THIS CONTRACT ONLY APPLIES TO THE ORIGINAL BUYER AND IS NULL AND VOID IF OWNERSHIP
IS TRANSFERRED. ALL SALES ARE CONSIDERED INITIATED, TRANSACTED AND FINALIZED IN LINCOLN
COUNTY, TN.

THE BUYER AGREES THAT ANY PHOTOS SENT TO THE BREEDER AFTER THE PURCHASE OF A
PUPPY CAN BE POSTED ON THE BREEDERS WEBSITE SO EVERYONE CAN SEE PREVIOUS
